Committee Participation

The Nominee will be expected to serve on at least one (1) committee, attend Club meetings, and engage in Club activities. The Brockville Rotary tradition is that members willingly respond to requests for Rotary service, unless there are compelling reasons why the individual cannot do so.

Attendance

One of the essential conditions of membership is regular attendance at weekly meetings. 60% attendance is a minimal acceptable standard set by Rotary International. However, the expectation is that the Nominee will endeavour to exceed this objective. Members can make up attendance for a missed meeting by attending at another Rotary Club, usually within 14 days. Committee meetings, fellowship events, and community service activities also count toward attendance credit. Membership may have to be forfeited if these conditions are not met or by failure to pay annual dues.

Photo Requirement

A professional business photo may be required for inclusion in the Member Directory and other Club communications.
